Digital Campus Platform Agreement

THIS AGREEMENT is made and entered into as of this 11/01/2021 (the "Effective Date") by and between ATSS IICMR, a institute located at Pradhikaran, Pune, India ("IICMR") and EventBee Technoservices Pvt. Ltd, with offices at BIEL, Shivajinagar, Pune, India ("Developer").

WITNESSETH

WHEREAS, IICMR desires to engage Developer to develop, create, test, and maintain a platform for Digitizing Campus of through a Web Panel, Android App & iOS app hence make the platform available for students & faculties.

WHEREAS, Developer is interested in undertaking such work; and

WHEREAS, IICMR and Developer mutually desire to set forth the terms applicable to such work;

NOW, THEREFORE, for the mutual consideration set forth herein, the adequacy of which is hereby acknowledged, IICMR and Developer, intending to be bound, hereby agree as follows:

1. Developer Responsibilities

A. Scope of Work

IICMR hereby retains the services of Developer to develop and host the services on its Website and App (collectively the "Platform") for IICMR in accordance with the proposal submitted by Developer to IICMR dated 11/01/2021 (the "Proposal"), a copy of which is attached hereto as Exhibit A and the terms of which are expressly incorporated herein by reference.

2. Platform Scope

A. Platform Scope

Developer agrees, at IICMR's option, to maintain IICMR's Platform on DEVELOPER's Web Server, and to make maintenance modifications to IICMR Platform from time to time in accordance with IICMR's directions. Such modifications shall be implemented within five (5) business days of DEVELOPER's receipt of IICMR's changes if the changes are easily implemented, and within ten (10) business days of DEVELOPER's receipt of IICMR's changes if the changes are not easily implemented.



3. Compensation

A. Price for Platform Creation

The Developer shall provide the platform, its hosting and timely maintenance WITHOUT any charge to the IICMR for a period of 12 months for all the students of the college

B. Price for Platform Hosting

Post the tenure of 12 months the platform charges for the servers, cloud storage, dedicated college storage per student a price of Rs 50/student/ lifetime. Shall be costed to the college

C. Expenses

Except as expressly agreed otherwise in writing by IICMR, Developer shall bear all of its own expenses arising from its performance of its obligations under this Agreement, including (without limitation) expenses for facilities, work spaces, utilities, management, clerical and reproduction services, supplies, and the like. IICMR shall have no obligation to provide office space, work facilities, equipment, clerical services, programming services, or the like.

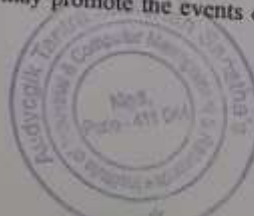
4. Ownership

A. Ownership of Work Product by IICMR

Except as set forth below, all elements of all Deliverables shall be exclusively owned by Developer and shall be considered works made by Developer for IICMR. Except as set forth below, Developer shall exclusively own all the company copyrights and all other intellectual property rights in the Deliverables. It is understood and agreed that additional materials added to the Platform in the future by Developer may belong exclusively to Developer. However, the parties agree that the ownership of any such future materials will be mutually agreed to by the parties.

5. Exclusivity of Digital Events Platform

- A. No individuals or entities other than Developer and DEVELOPER's employees and independent contractors shall undertake any work in connection with this Agreement. The developed platform shall be an exclusive platform for promotion & registration (online & offline) for attendance, material exchange between students & all college events under IICMR. The event organizers may prepare an independent site for the detailed description of the events however event organizers cannot use other payment gateway or ticketing platform for registrations of their event. However, the organizers may promote the events on



social media and other advertising means as mentioned by the Developer. The developed platform to be sole platform used for accepting registrations, payments & intimating students with events of their interests.

6. Term and Termination

A. Term of Agreement

This Agreement shall be effective as of the Effective Date and shall remain in force for a period of 1 year, unless otherwise terminated as provided herein.

B. Termination of Work

IICMR & Developer, at its mutual consent terminate any or all work outstanding, or any portion thereof, immediately upon written notice. Upon receipt of notice of such termination, Developer shall inform IICMR of the extent to which performance has been completed through such date, and collect and deliver to IICMR whatever work product and Deliverables then exist in a manner prescribed by IICMR. Developer shall be paid for all work performed through the date of receipt of notice of termination as specified herein.

Developer may not terminate any work under this Agreement without the prior written consent of IICMR.

C. Survival

In the event of any termination of this Agreement, all obligations and responsibilities of Developer shall survive and continue in effect and shall inure to the benefit of and be binding upon the parties and their legal representatives, heirs, successors, and assigns. The termination of any provision of this Agreement shall not excuse a prior breach of that provision.

D. Termination for Cause

This Agreement may be terminated by both party upon thirty (30) days written notice to the other party in the event of a breach of a material provision of this Agreement by the both party, provided that, during the thirty (30) days period, the breaching party fails to cure such breach.

7. CONFIDENTIALITY OF STUDENT'S & FACULTY DATA

A. Developer is obligated to maintain the confidentiality of any such private personal information that is encountered.

B. College expects Developer with access to personal information to deal with that information in a respectful and professional manner. As a matter of policy, the College restricts access to personal information of the College Faculty, Students &



IICMR. Access and release of any student educational records must be in accordance with IICMR's regulations. Access and release of any event records must be in accordance with IICMR's regulations. Any personal information viewed or accessed by the Developer through College systems or records is not to be shared or released to others.

- C. Inappropriate disclosure of information pertaining to students, faculty, staff and other college constituents may violate applicable law and regulations and is considered a violation of ethics and a breach of trust placed in the Developer by the College. Faculty, student, financial, and registrations information contained within IICMR's panel information systems (electronic and physical files) and external documents sent is considered confidential. Access to information made confidential by law or campus practice is limited to those individuals (employees, consultants, adjunct professors, third-party vendors, etc.) whose position legitimately requires use of this information.

As a Developer of Digital app for the College, Developer agrees to abide by the following guidelines:

1. Understand and acknowledge that improper or inappropriate use of data in the College's information systems is a violation of College policy, and it may also constitute a violation of laws.
2. Not provide confidential information to any individual or entity without proper authorization or students consent.
3. Not access, use, copy or otherwise disseminate information or data that is not relevant and necessary to perform my specific event-related duties.
4. Not remove confidential information from College facilities except as specifically authorized to do so.
5. Not access or view user id and password with anyone, including support staff. Access can be granted in some instances by request to the Office or Faculty Head.
6. Not use the data for personal or commercial purposes.
7. Refer external requests for all College statistical, academic or administrative data to the departments that have been authorized to respond to such requests.
8. Not communicate anyone's personal identifying information to the general public.
9. Report any unauthorized access of confidential data immediately to IICMR
10. Understand that any improper or inappropriate use of data in the College's information systems may result in disciplinary action pursuant to the applicable collective bargaining agreement, up to and including termination of developer's contract.
11. Understand that when storing confidential data on College servers, they must on an operational basis remove files containing confidential data when it is no longer needed.
12. Understand that if they are uncertain about what constitutes legitimate use or release of information they should always consult on the side of confidentiality and refer questions about the appropriateness of a request for personal information from College systems or records to IICMR.


